FEE PAYMENT AGREEMENT

1. REGISTRATION FEE

I understand a non-refundable registration fee of \$75.00 is due with this form to reserve a spot (weekly or daily) for my child. Registration fee includes two (2) t-shirts to be worn on field trip days. Your child's size must be selected below.

2. CAMP PAYMENTS

I/we agree to pay the above selected WEEKLY payments by the end of Monday of selected camp week. I/we understand that Christ Chapel Academy will issue me a camp coupon book. I/we understand that if coupons are not included with payment, a fee of \$10.00 will automatically be added to the account and is due at time of payment. If a new coupon book needs to be reissued after CCA has issued my child's 2017 Summer Camp coupon book, I/we will be assessed \$25.00 per book which is due within five days. If after one missed payment, Christ Chapel Academy (CCA) has the authority to not allow my child to attend the Camp program until my child's account is current and I understand that my child's position may be lost.

3. EMERGENCY CARE

Unscheduled Emergency Before or After School Care: I understand that if my child is dropped off before 9:00 AM or not picked up by 3:30 PM, I will be charged an hourly rate of \$20.00 for unscheduled emergency care if they are not registered in the before and/or after care program. I understand that payment is due in full at the time of service or by the end of the next business day to avoid a \$25.00 late fee that is due at time of payment. I understand that there is a minimum of one hour charge with one-half hour increments thereafter.

Scheduled Emergency Before and After Care (24 hour online notice required): I understand that I can schedule before and/or after care, based on availability, if students are not registered in the before and/or after care 24 hours in advance for an unexpected situation; I will be charged \$15.00 an hour. I understand that payment is due in full at the time of service or by the end of the next business day to avoid a \$25.00 late fee that is due at time of payment. I understand that there is a minimum of one hour charge, with one-half hour increments thereafter. I understand that if the 24 hour online notice is not provided, I will be charged the Unscheduled Emergency Care rate of \$20.00 an hour with payment due at time of service. 4. PENALTY FEES

In the case the Summer Camp Payment is not received by the end of the Monday of the weeks I have selected, a \$25.00 late fee will be charged and is due at time of payment. If the summer camp payment date falls on a holiday, payment is due by the end of next business day to avoid a late fee of \$25.00. A \$25.00 charge will be added to the account for any returned or stopped payments and payment must be made within ten days to avoid any additional fees. If there are two or more returned payments on the account, payments will be made in cash, cashier's check or money order. If payment is not received by cash/check within five business days, a \$25.00 late fee will be charged to the account and is due at time of payment. If an account is delinquent over 60 days from the due date, a 1.5% charge will be added to the account balance as well as the late fee.

If coupons are not submitted with payment, a fee of \$10.00 will automatically be added to the account and is due at time of payment. A \$25.00 fee for re-issuing or reprinting an additional coupon book(s) after they have been originally issued by CCA will be charged to the account and is due within 5 days of receipt of the re-issued/reprinted book(s).

5. ACCOUNTS SENT TO COLLECTIONS

In the case of a past-due account being sent to collections, the balance of any outstanding payments, plus collection, court and/or filing legal fees will be added to the balance owed to Christ Chapel Academy.

6. CANCELLATION OF CAMP WEEKS

I understand that I can select the weeks of my choice but will be responsible for payment of every week selected unless the school is given **two-week advance notice in writing** that my child will not be attending camp. If the school does not receive a two-week written advance notice, I am responsible for the weeks selected whether I use the service or not.

7. ADDING ADDITIONAL WEEKS

In the case of adding additional weeks, I understand that if I provide less than two-week advance written notice for the added weeks, there will be an additional charge of \$25.00 per week automatically added to my child's account.
